This is for the purchase of a F1 Miniature Goldendoodle puppy described above, Purchaser(s) agrees to pay Rural Station (Breeder) \$2500 (two-thousand five hundred dollars) for the sole ownership of the F1 Miniature Goldendoodle puppy, which will be secured with the Purchaser deposit of \$1250 (one thousand two hundred and fifty dollars), with the Breeder, which will go towards the total purchase of the F1 Miniature Goldendoodle puppy.

Based on the Breeder's knowledge and experience, it is believed this puppy to be in good physical and mental health at the time of final sale. The puppy will have been examined and determined to be in good health at PetPlex Animal Hospital, 4200 Walnut Rd, Buckeye Lake, Ohio 43008 (740) 929-3300.

Buying and raising of a puppy involves a certain amount of emotional and financial risk. The Breeder is not responsible for any medical bills, whether expected or unexpected and that the Purchaser will have the puppy examined by a veterinarian within 72 hours of taking possession.

If, before 2 years of age, the puppy in this contract dies of an inherited condition or is not able to be a functional pet and you followed our guidelines for vaccination, neutering/spaying, and care, and our veterinarian agrees with the condition/problems of the dog, we will at our option, replace the dog or refund the purchase price. If we opt for replacement, you will be placed at the top of our waiting list for a suitable pet puppy. IF YOUR PUPPY IS PRECIBED BY ANY VETERNAIRAN ORAL FLEA AND TICK WITHIN THE FIRST 2 YEARS OR IF NEUTERED/SPAYED BEFORE 2 YEAR OF AGE WITHOUT OUR WRITTEN PERMISSION, ALL GAUARENTEES, REFUNDS AND REPLACEMENTS ARE VOID.

The Breeder feels a life-long responsibility to this dog. If at anytime you are unable or unwilling to keep the dog, you promise to return the dog to us. IF THIS DOG IS EVER IN THE POSSESSION OF A RESCUE OR SHELTER OR IS PICKED UP BY ANYONE AS A STRAY, OWNERSIP REVERTS IMMEDIATELY TO THE BREEDER.

The Purchaser expressly consents to the exclusive jurisdiction of the state or federal court jurisdiction in Licking County, Ohio for the resolution of any disputes related in any way to this contract or services provided by Rural Station LLC, or its Breeder.
